Our bus will depart from the Hilton Capitol Center Hotel at 11:00 a.m. We will stop for lunch at a restaurant in New Orleans and then continue to the Louisiana SPCA in New Orleans. It was the lead animal welfare agency responding to Katrina disaster. It rescued, provided water, food, shelter, and transported over 11,000 animals to safety following the hurricane. The storm destroyed the shelter so the facility we will visit is the new shelter. Ana Zorrilla, the CEO, will be our host. We will depart the shelter at about 3:30 p.m. and return to the hotel by 4:30 p.m. *Pre-registration is required for this event.*

The Board of Animal Grantmakers will have a dinner meeting at the hotel from 6:00 to 7:30 p.m.
- 8:00 p.m.**      **Screening of the Movie *The Cove*:**  
Academy Award® Winner for Best Documentary of 2009, *The Cove* follows a team of activists, filmmakers and free divers as they embark on a covert mission to penetrate a remote and hidden cove in Taiji, Japan. Utilizing state-of-the-art techniques, including hidden microphones and cameras in fake rocks, the team documents the annual dolphin drive fishery in this small seaside village, in which hundreds of dolphins are slaughtered for meat or captured for sale to aquariums and sea parks.

This year's conference will be held at the Hilton Baton Rouge Capitol Center. Originally built in 1927, it re-opened in September 2006 after having been closed for 25 years. Over 70 million dollars in renovations has brought this grand hotel back to its glory. In 1986 the hotel was placed on the National Register of Historic Places and it is now one of 212 Historical Hotels of America.

Every room has a view that overlooks either the Mississippi River or downtown Baton Rouge. Each guestroom has a unique floor plan which includes a comfortable work area with a desk and rolling, high back chair, high speed internet access, wireless access, in-room coffee maker, hair dryer, individually controlled digital thermostat, iron/ironing board, and in-room safe. Weekday newspaper delivered. Choose between a king or two double beds depending on your preference.

For the conference, a block of rooms has been reserved at the special rate of **\$139 per night** for three nights — Sunday, November 14th; Monday, November 15th; and Tuesday, November 16th. (Rate does not include taxes totaling 13%.) If you wish to come early or to extend your stay, the hotel will honor these rates for two days prior to, and two days following the conference.

The special rate is available for a **limited number of rooms** on a **first-come, first-served** basis. **RESERVATIONS MUST BE MADE BEFORE OCTOBER 14, 2010** in order to take advantage of the special rate. After that date, any unused rooms will be released and the conference rate will no longer be available. Room cancellations must be made **72 hours in advance** to avoid a charge for one night's stay.

- **Pre-Conference Site Visit:** On Sunday, November 14th, you may join a site visit to the Louisiana SPCA. This facility is new as the prior shelter was destroyed during Hurricane Katrina. The LA/SPCA was the lead animal welfare agency responding to the Katrina disaster. CEO Ana Zorrilla will be our host and guide for this tour. We plan to leave the Hilton Hotel by bus at 11 a.m., have lunch in New Orleans, spend 2 hours at the shelter, and return to the Hilton by about 4:30 pm. Cost of this field trip is \$75.

- Monday Night Dinner Guest: Your spouse or partner is welcome to attend our served dinner on Monday evening. A fee of \$50 is charged to defray the cost of accommodating your guest.

**Payment Calculation**

- Paid members of Animal Grantmakers receive free conference registration for two people. Additional representatives must pay a registration fee of \$400 per person.
